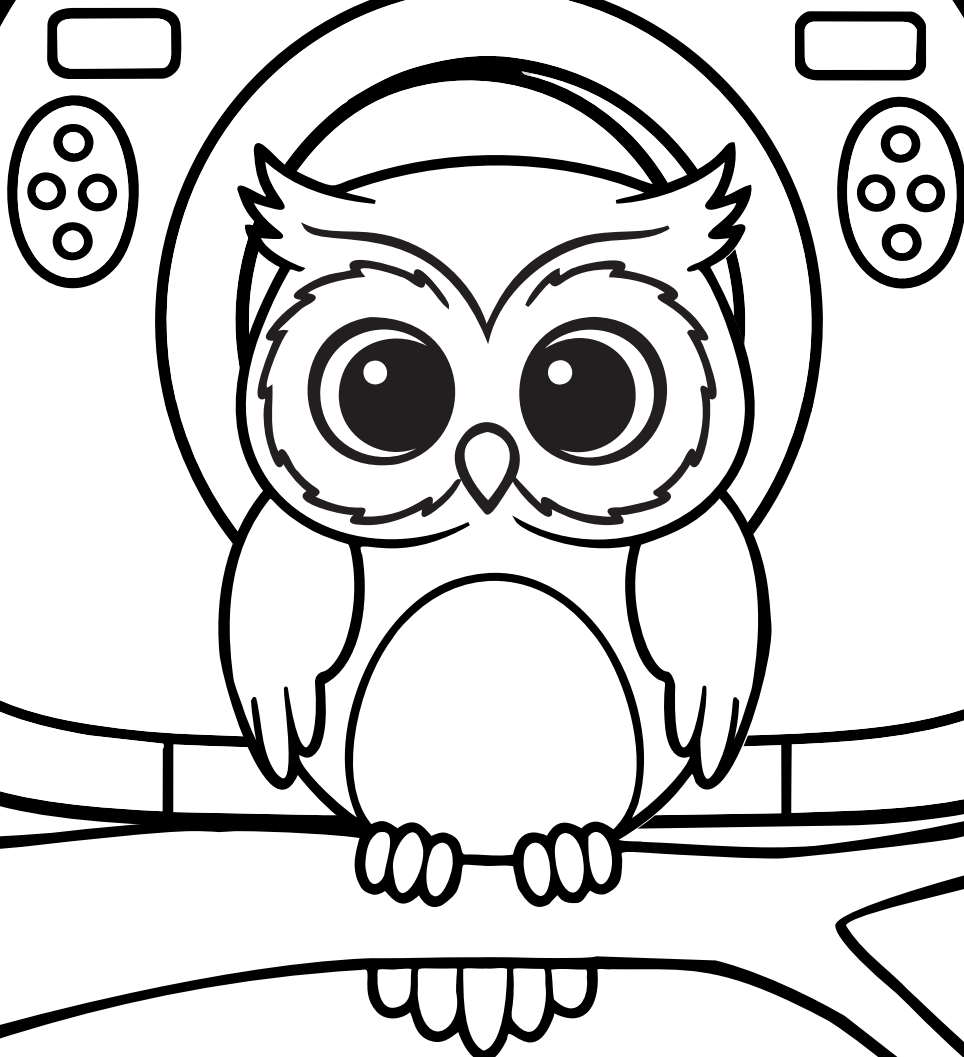

Colouring Contest Rules

Contest Dates

MIC's Colouring Contest begins August 1st, 2026, and closes August 31st at 11:59 PM MST, 2026.

Eligibility

The colouring contest is open to **ALL children 13 and under**, with one (1) entry per child, plus five (5) extra entries when the photo is tagged and shared to your stories on Instagram. **Participants DO NOT need to have a service performed or scheduled at MIC to enter.** The contest is open to Alberta residents only and the prize must be claimed at one of our MIC clinic locations.

How to Enter

- **Pick up or download** the colouring page handout:
 - Talk to a receptionist or technologist at any MIC clinic to receive your copy.
 - Download the page from our website (**www.mic.ca**) and print a copy for your child.
- Have your child colour the page and include their first name and age.
- Upload a photo of the completed artwork (with or without your child in the photo) to Instagram and tag **@micmedicalimaging**. This counts as one (1) entry.
 - Optional: share the post to your stories and mention **@micmedicalimaging**. This counts as an additional five (5) entries.
- **Please note:** If you have a private account on Instagram, you will have to screenshot your post(s) and send them (timeline & story) to MIC as a direct message so we are correctly notified of your participation.

Winners & Prizes

Participants must enter the draw by 11:59 PM MST on August 31st, 2026. **The winner will receive a \$100 Gift Certificate to Mastermind Toys.** A winner will be **drawn at random** and contacted through private message to arrange a convenient pickup location.
